Franciscan Children's Affiliation

- In July 2023, Boston Children's finalized an institutional affiliation with Franciscan Children's to enhance the system of behavioral health care and improve care for children with complex rehab needs
- The partnership includes creating a state-of-theart new building for children's mental health and rehab needs on Franciscan's Brighton campus
- As a result of this opportunity, there is a new funding opportunity for community organizations







Determination of Need Community Health Initiatives



- Massachusetts is one of 35 states with a Determination of Need Community Health Initiative program, regulated by the MA Department of Public Health
- The State requires 5% of capital project costs to be allocated to community health initiatives
- Required community engagement process
- Opportunity to build and expand community partnerships

Initiative Overview

Goal: Improve the mental health of Boston youth *ages 11-24* through positive social connections

Grant funding will support a **partnership** whose efforts are focused on identifying hard-to-engage youth and connecting them to programs/services

Priority populations:

- Youth in foster care
- Court-involved youth
- LGBTQ+ youth
- Immigrant youth
- Neurodivergent youth

Boston Public Schools, Boston Housing Authority, Department of Youth Services)





Project Examples

- 1. A **youth development organization** partnering with its local **housing development** to identify youth that may not be engaged in other community activities and families who have not participated in community events
- 2. A youth **arts program** partnering with a specific **school** to identify youth who are not engaged in any extracurricular activities
- 3. A youth **mentoring program** partnering with a **public agency** that works with court-involved youth and their families to provide wraparound services and support
- 4. A **faith-based organization** partnering with a **welcome center** that serves newly arrived immigrant families to get youth connected to programs/services and embedded in their community
- 5. An **LGBTQ+ youth organization** partnering with a **foster care organization** to provide identity-affirming academic and social support services
- 6. A **neurodiversity support group** partnering with a **neighborhood coalition** to activate community spaces for inclusive programming





Grants Overview

- Three-year grants: June 1, 2025 May 31, 2028
- Can apply for \$50,000 to \$100,000 per year (\$150,000 to \$300,000 total)
- Total funding available: \$1,200,000
 - Anticipate funding up to 6 partnerships
 - $_{\odot}\,$ Competitive process
 - Selection committee comprised of Boston Children's staff as well as external and community representatives

- Neurodivergent youth

If you serve other neighborhoods/cities, you can still apply but your application will be considered within the context of the applications received from our priority neighborhoods.






Selection Criteria

- 1. Track record of meaningful youth engagement and connection to community
- 2. Strong partnership with clearly defined roles and evidence of (or potential for) successful collaboration
- 3. Alignment with initiative's strategy and priority populations
- 4. Clear, comprehensive description of project and how it will engage new youth
- 5. Potential for positive impact on youth mental health and well-being
- 6. Outcome metrics that are relevant, measurable, achievable
- 7. Sufficient staff capacity to successfully implement and evaluate project
- 8. Budget that accurately reflects level of project effort





Application Process Timeline






